## Surcharge, Wheeling Charge & Transmission Charge for Open access consumer 1MW & above

## EFFECTIVE FROM 4<sup>th</sup> April 2021

In exercise of the powers conferred under Sections 39,40 and 42 of the Electricity Act, 2003 read with the provisions of OERC (Terms and Conditions of Intra State Open Access) Regulations, 2020, the Odisha Electricity Regulatory Commission has passed Common order on 26.03.2021 in Case Nos.**79**, **80**, **81& 82(A) of 2020** with regard to approval of Open Access Charges (Transmission/wheeling Charges, Surcharge and Additional Surcharge applicable to open access customers for use of Intra-state transmission/ distribution system) which shall be effective from 4<sup>th</sup> Aril, 2021.

2. The wheeling charge and surcharge as indicated in Table below shall be applicable w.e.f. 04.04.2021.

3. The normative transmission loss at EHT (3.0%) and normative wheeling loss for HT level (8%) are applicable for the year 2021-22.

4. Additional Surcharge: No additional surcharge over and above the Cross-Subsidy Surcharge needs to be given to the embedded licensee.

- 5. No Cross-subsidy surcharge are payable by the consumers availing Renewable power.
- 6. 20% Transmission & Wheeling charge is payable by the consumer drawing power from Renewable source excluding Co-generation & Bio mass power plant.
- 7. These charges as notified for the FY 2021-22 will remain in force until further order.

For the information of the General Public and interested persons, the Commission hereby publishes the charges as would be applicable for all classes of consumers at HT & EHT. The said order shall be available in the Commissions website <u>www.orierc.org</u> as well as in the website of the Distribution Utility <u>www.tpwesternodisha.com</u>.
